Regarding the above subject, Sri Tirumala Education And Charitable Trust, Sathanur has submitted a proposal in the reference copy for granting recognition under the RTE Act to Saketh Mother Teresa Private Unaided School, which is running from Nursery to Class 9 for the year 2024-2025.

In this regard, the said school was visited on 10-12-2024 and the basic facilities were inspected. The said school has been granted permission by Sri Tirumala Education and Charitable Trust to run the school permanently without grant in English medium for classes 01 to 05 in the year 2012-13, 01 to 06 in the year 2013-14, 01 to 07 in the year 2014-15, 01 to 08 in the year 2015-16 and 9th and 10th in the year 2016-17. There are 26 classrooms, separate toilets for boys and girls, playground, computer lab, CCTV, library, science laboratory, indoor stadium, ramp facilities. The basic facilities in the school are in good condition. And the building has obtained a building fitness certificate from the PWD Department and necessary steps have been taken as per the Fire Safety Policy 2016. The school's enrollment for the year 2024-25 is as follows.



Regarding the above subject, Saketh Mother Teresa Private Unaided Higher Primary School, which has been running since 2022-23 under the Sri Tirumala Education and Charitable Trust, Sathanur, has obtained the approval of the Central Curriculum (CBSE) (Affiliation Number 831387) (School Code-47024) and is running from Class 1st to Class 9th. As per the guidelines of the department, we submit an application for renewal of accreditation online and offline by following all the checklists in Form-1 given by the department. As per reference (1), the Honorable Block Education Officer, School Education Department, Kanakapura Taluk, visited our school and inspected it. In Form-1, the Honorable Deputy Director (Administration) School Education Department, Ramanagara District gave a written opinion that the accreditation can be renewed. In this regard, the Honorable Deputy Director (Administration), School Education Department, Ramanagara District, after realizing that there is a delay in granting the accreditation/recognition renewal despite fulfilling all the guidelines of the department, has inquired and as per reference-2 mentioned, he has verbally informed that the department will not allow CBSE schools to grant RR accreditation/recognition acceptance online and offline.

Therefore, in the educational interest of the children, we request you to review the said application for renewal of accreditation/recognition and consider that the guidelines has been followed as per the department and request Honorable Deputy Director (Administration), School Education Department, Ramanagara District to give appropriate instructions and to the renew the accreditation/recognition of our school and to issue a recognition letter.

3. The Child Rights Education Act 2009, under the rules made there under, reserves 25% of the seats for weaker section children. The government has the authority to enroll the seats reserved by the government for schools falling under the purview of RTE under RTE [The government has made rules to facilitate the enrollment of children in schools near the residence of their parents, and accordingly, if there are government or government-aided educational institutions, the children will be enrolled in that school]. In case there is no such thing, private schools will enroll the children enrolled by the government and allow them to continue their education from the primary stage to the secondary stage. These children will be given the opportunity to continue their studies without any discrimination.
4. As explained in Section 3, the government waives the fees of children enrolled under the RTE Act as per the rules. It has prohibited the collection of any fees from these children.
5. The school administration is prohibited from collecting any voluntary donations from parents, either at the time of registration or later, in any form, in addition to fees and any kind of capitation fee.
6. The school/board of management shall publish the information on the fees collected from the parents of the children in the school as tuition fees in accordance with the State Government Notification No. ED:31:PGC:2019, Dated 27-07-2019 on the department website and in the school notice board. No additional fee shall be collected beyond the prescribed fee.
7. The school/board of management shall enroll the students within the period fixed by the government.
8. The school/board of management cannot deny admission against the following factors.
 - a. Due to lack of age proof.
 - b. On the basis of caste, religion, place of birth, language
 - c. Requested admission after the admission grace period.
9. All safety measures as per RTE Act and Rules Karnataka Education Act and Rules are being taken. [Fire Safety and Building fitness Certificate from concerned authorities and Safety of Children's Learning as per KSCPCR and NCPCR]
10. The school/board of management is as follows:
 - a. No child admitted to the school shall be held back in any class or expelled from the school before completing primary education and secondary education.
 - b. No child should be subjected to physical or mental abuse.
 - c. No child is required to pass any board exam to complete primary education.
 - d. For those who complete primary education, a certificate is issued to each child as prescribed under RTE Rule 21 and the Karnataka Education Act and Rules.
 - e. As per the provisions of the RTE Act and Rules and the Karnataka Education Act and Rules, the school must also accommodate children with special needs.
 - f. The appointed teachers shall have a minimum educational qualification as prescribed for primary and secondary school teachers in the RTE Act and Rules and the Karnataka Education Act and Rules and Government Orders.
 - g. The salary and allowances payable to teachers and the terms and conditions of service shall be as prescribed by the State Government. The salary of teachers shall be paid through Government Provident Fund (PE) and other payables from the bank and other sources. The employee shall be covered by the Employee State Insurance (ESI).
 - h. The teachers shall perform the duties prescribed under Section 24[I] of the Act and RTE Act and Rules and Rule 17 of the Karnataka Education Act and Rules and shall not engage themselves in private tuitions for supervision considerations.

1. The school shall follow the affiliated state education curriculum and state textbooks.
2. To administer the rules and regulations as specified in Section 19 of the Karnataka Education Act. To appoint the departmental staff as prescribed in the Karnataka Education Act and Rules.
3. School buildings and other infrastructure facilities related to schools should not be given over to any commercial activities or political and educational activities during the day or night.
4. The school should not be run for the profit of any individual or group or association.
5. School shall get audited by a Chartered Accountant and submit a copy to the Deputy Director/Block Education Officer by the end of June every year.
6. The school will follow the language policy as per the government notification [Kannada Language Policy 2016].
7. The managing body and the teachers will function as per the RTE Act and the Karnataka Education Act and Rules.
8. School/board of management should strictly follow the rules and directives of the government and department.
9. School records are to be mandatorily uploaded to SATS as per the rules by the end of March every year.
10. In case of violation of the above conditions, the school's recognition will be cancelled as per the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.
11. After the process of school recognition is completed, the school administration will make the complete documents/information in the application submitted online publicly available on the departmental website.
12. In case of violation of the above conditions, the school's recognition will be cancelled as per the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.
